Discontinuation of Degree

The School of Music would like to discontinue the stand-alone degree in Music Therapy (CIP 51.2305). There is a curriculum proposal in process that will reorganize this degree as a concentration, but the Music Therapy CIP code will cease to be used at ECU. Proposals to the UCC for this reorganization will be considered at the March 21, 2013 meeting of the committee.

Students presently in this degree will be allowed to complete their program and new students will be placed into the reorganized degree concentration. The transfer should be seamless and hardly noticeable to the students. Conversations with the Office of the Registrar have assured me that the impact on transcripts and diplomas will also be minimal.

The remaining faculty member will continue to teach in this area for the foreseeable future as course offerings will not change with the reorganization to the concentration area.
