



It is with great regret that we write to recommend the discontinuation of the Bachelor of Arts Degree in Women's Studies at East Carolina University effective Fall 2013. We will continue to offer our undergraduate and graduate minors in Women's Studies.

This decision was discussed and voted upon by the Executive Committee of the Women's Studies during the Fall 2012 semester. The Executive Committee and the Director have worked for a number of years to raise the number of majors in the program, so as to remove it from low productivity standing. While student credit hour generation has more than tripled in the last three years, the number of majors in the program has not increased.

It is the decision of the Executive Committee that the degree cannot be sustained without dedicated faculty lines to facilitate the offering of additional courses, student recruitment, and mentoring. As these lines are not forthcoming, the Committee feels that it has no other option but to discontinue the program.
