1. Briefly describe the proposed program and intended audience.

The master of arts in middle grades education degree program allows completion of an advanced degree for individuals who presently hold an initial 6-9 Middle Grades teaching license. This degree program will be available to serve all North Carolina's pre-service and in-service teachers and ultimately serving all citizens of North Carolina by providing higher quality of education for its citizens. The students enrolled in ECU's MAEd in middle grades education program will be able to participate in advanced study of both content and pedagogical issues. As emerging leaders in their schools and districts, students work closely with education faculty to design innovative research projects that contribute to the Middle Grades Education field. A nine-hour content area

strand is selected from areas including courses in advanced methods, gifted education, library science, digital literacy/technology integration, and/or teaching English as a second language.

2. Describe the proposed instructional delivery systems (e.g., on-site instruction, interactive video, Internet, etc., including combinations of these).

The program will be delivered via the Internet utilizing Blackboard as the course management system.

3. Describe need for the program (referencing results of surveys or special studies). If site-based, is any other institution (public or private) offering a similar program in the location(s)? If online, are any other UNC institutions offering a similar online program?

Typically those teachers who are interested in pursuing an MAEd in middle grades education are those individuals who have leadership roles in their schools, districts, and the public school community. Obtaining this degree through online instruction will enhance the opportunities for these working professionals to serve the public schools of North Carolina in important leadership positions. A survey of our current MAEd students indicated an overwhelming preference (98% of respondents) for 100% online instruction for all courses. A 100% online program will allow ECU to better serve both current and potential MAEd students who (1) do not live in close proximity to a UNC campus; (2) work full time and need the flexibility of asynchronous learning; and (3) desire professional growth.
