	progress and practicum experience through professional writing. The writing assignments enable the student to demonstrate the learning outcomes and increase their professional writing skills.

Each student will be required to include the Practicum Final Report assignment in his or her BSUS e-portfolio. The BSUS e-portfolio serves as a degree program assessment tool. The Practicum Final Reports will also be uploaded as the writing sample to the University Writing Portfolio.

University Writing Across the Curriculum Committee Writing-Intensive Course Proposal

The following outcomes represent the ECU Writing Outcomes approved by the WAC Committee. Explain how the projects and activities in your proposed course help students to meet these outcomes.

SLO How will students use writing to investigate complex, relevant topics and address significant questions through engagement with and effective use of credible sources?

Through all four assignments, students will be expected to investigate details of their practicum plan and illustrate the relevancy of their practicum's contribution to their curriculum thematic core and career plan.

SLO How will students produce writing that reflects an awareness of context, purpose, and audience? If this is a WI course specific to majors, please explain how students will produce writing that reflects an awareness of context, purpose, and audience in written genres of their major disciplines and/or career fields.

UNIV 4990 is specific to University Studies Majors. The course serves as the capstone course for majors and is designed to bridge the student's curriculum thematic core to their career objectives. Most of the written assignments are required to be reviewed by the student's practicum supervisor, a process that will provide constructive feedback to context, purpose, and audience.

SLO How will students demonstrate that they understand writing as a process that can be made more effective through drafting and revision?

The practicum supervisor, prior to submission, will review the assignments. The Bi-Weekly Reports assignment will provide feedback for revisions to the subsequent reports and student will be assessed on improvement to reports. The Practicum Proposal will not be approved until feedback for revisions are addressed.

SLO How will you help students proofread and edit their own writing, avoiding grammatical and mechanical errors?

The UNIV 4990 instructor will review and assess Practicum Proposals for corrections and approval. The practicum supervisor will provide review of all assignments prior to the practicum instructor assessing and grading the assignment. Both the practicum supervisor and instructor will provide final assessment of the student's written communication skills.

SLO How will students assess and explain the major choices that they make in their writing?

The Practicum Proposal assignment must clearly illustrate a connection between the student's curriculum plan and his/her post-graduation plan. The Practicum Final Report and Poster Presentation will require the student to illustrate how their practicum experiences have equipped and prepared them for post-graduation goals.
