ANNUAL REPORT TO FACULTY SENATE

PARKING AND TRANSPORTATION SERVICES

January 2017

The Department of Parking and Transportation Services (P&T) reports to the Division of Administration and Finance. It consists of the following areas: parking lot inventory management and enforcement, parking permit sales, finance and administration, motor pool management, special events coordination, and transportation demand management (TDM). Transportation demand management utilizes alternative transportation to minimize parking demand and traffic congestion and includes ECU Transit (Student Affairs), bicycles, pedestrian, carshare and rideshare.

Parking is required by NC law to be self-supporting. We receive no state funding. Our primary goal is to keep permit fees as low as possible and base fees on paying for convenience. To continue in the maintenance and upgrade of existing parking resources and plan for future parking demand, we are researching additional avenues for revenue. We have increased revenue by expanding parking fees for events by internal and external customers This year a 2% fee increase has been approved by the Board of Trustees and will be implemented to increase revenue in July 2017. The fee increase is as follows:

Parking Inventory

There are currently 12,738 parking spaces that are owned by the University. These spaces include permit, ADA, service, visitor, and patient parking spaces. The number of available permit parking spaces is 9046. These spaces need to satisfy parking demands of 28,380 faculty, staff, and students. Current space counts include a reduction of 464 spaces and addition of 244 new spaces. The space reduction came from south of Mendenhall and Joyner. The space additions were from lots at 10th and Evans and 14th at College Hill. The current spaces by location are as follows:
