- 3. The committee completed all routine business by established deadlines and facilitated communications in preparation for three different awards ceremonies held through the Spring 2019 semester.
- 4. The committee continued its discussion and review of the proposed Selection Procedures for Annual Service-Learning Teaching Excellence Award. After the final meeting for the committee, funding was acquired for this award in the amount of \$1000 annually from the Provost. Student Affairs will also give a *non-academic* award in the amount of \$1000 annually.
