    This item was presented to Faculty Senate (23 April 2019) and returned to our Committee.

    Following a brief discussion with Donna Gooden Payne, at that meeting, in order for such a policy to be approved, it must not exclude anyone who might legitimately attend a class meeting, which may require articulating what ought to have been obvious for a long time. It might instead be worth the Committee considering whether it already falls under an instructor's responsibilities to ensure that no one attends class whose attendance is not justified.

- 7. Evaluation of the committee (Include anything that hindered or assisted the committee's work during the year.)
  - A. Charge: Sufficient
  - B. Personnel: Current personnel is adequate.

- 8. Suggestion(s) to the Chair of the Faculty and/or Faculty Senate for improving the effectiveness of the committee.

Several of the issues the Committee was asked to consider involve writing policies for the Faculty Manual to explicitly provide instructions for actions which it is already an instructor's responsibility to take. Although it should not cause any harm to write these policies, it turns out that they provoke thorny legal issues. For example, the Student Visitor to Class with neither Prior Notice nor Permission requires a policy which articulates exactly what persons are permitted to attend a class, under all variety of circumstances, including guests invited by the instructor, monitors invited by administrators, peer reviewers of teaching, and prospective students. The burden of proof for attending a class falls upon anyone present, and it raises a security issue for a person (or animal) to attend class with neither prior notice nor permission. I submit that the Faculty Chair, perhaps together with other faculty and campus administrators, discuss a metapolicy for determining which issues genuinely require policy changes to the Faculty Manual. The Excused Absence Policy seems may turn out to be the same sort of issue, since the problem seems to arise from not adhering to existing policies, rather than a new sort of problem.
