Accomplishments during the year. Please include recommendations made to any University agency other than the Faculty Senate.

- A. Revised the Undergraduate Curriculum Committee charge to include: "The committee ensures that proposals adhere to best practices in higher education and agreed upon academic standards." The committee also updated language in the charge to reflect current committee names (Council for Teacher Education was updated to Council for Educator Preparation).
- B. Established a consent agenda process for uncontroversial packages, which is determined by the members of the committee prior to the meeting date. The consent agenda allows originators not to attend meetings for minor curriculum changes.
- C. Reviewed courses banked for 5 or more years. The committee drafted an email that was distributed to all affected units that outlined these courses would be deleted if a justification to keep them was not provided by the provided date. The committee reviewed and voted on the justifications to keep the outlined courses and delete the remaining courses. This process led to the deletion of 63 courses from the undergraduate catalog.
- D. The UCC held an extra meeting to review and approve curriculum packages on March 26, 2020 to provide more units the opportunity to meet the 2020-2021 catalog deadline.
- E. The UCC continued to utilize the commenting feature in the proposal forms in Curriculog to alert originators to small errors/questions about proposals before the meetings. This practice allowed originators to address those issues or answer those questions before the meeting in many cases, and the meetings were more efficient and fruitful as a result.
- F. The UCC reviewed 403 curricular actions.
