Karen Vail-Smith served as committee representative on the University Athletics Committee.

September 21, 2020" The committee agreeed with the Faculty Chair that the unit administrator, chair of the personnel committee, and unit faculty members may develop a mutually agreeable schedule for peer observations in light of ECU's

operating procedures during the Covid-19 pandemic. The Faculty Manual allows for flexibility in the timing of peer review observations for probationary faculty, requiring a total of 8 observations during the first five years of a six-year probationary period. For fixed term faculty, a unit may postpone observations because other measures are available to determine teaching effectiveness. However, if a fixed-term faculty member requests peer observation (for face-to-face or online classes) the unit should accommodate that request.

September 21, 2020: The committee agreed with the Faculty Chair that the Chancellor's policy governing the opening of the campus prohibits classrooms being occupied at greater than 50% of their normal size limit. Therefore, peer observers should not be allowed into a classroom that is at maximum capacity.

September 21, 2020: The committee agreed with the Faculty Chair that the pre-observation meeting, which is a required part of the overall peer observation procedure, should address anything that does not conform to the expectations of the peer-observation criteria currently in place in the unit, such as a shift to online-teaching, conversion to a flipped classroom, or other changes in teaching duties and activities due to ECU's response to Covid-19.

September 21, 2020: The Committee voted to recommend to the Provost that ECU proceed as normal for fall 2020 SSOI surveys.

September 21, 2020-April 19, 2021: The committee discussed the presence and impact of bias against underrepresented populations in the SSOI.

November17, 2020: The committee met with Wendy Creasey (Provost's office), who gave a presentation on the use of artifical intelligence(AI) applications I to grade student papers and essays. Committee members discussed weaknesses and potential issues steming from the fact that AI does not actually read what it is grading.

February 15, 2021: The committee approved a rubric to use when evaluating the syllabi to provide assessment reports on syllabi to IPAR.

February 15, 2021: The committee recommended to the Provost that the results of the SSOI be distributed and used in annual evaluations as required by the faculty manual. The committee requested that the Provost send a memo to faculty encouraging them to encourage their students to complete the spring SSOI. The committee requested that the Provost remind unit administrators to us the SSOI results in accord with the requirements of the Faculty Manual policy on evaluating teaching.

March 15, 2021: The committee recommended that IPAR analyze the Spring 2019 and Fall 2019 SSOS results (numerical and student comments) and provide the committee with a report on whether the results provide evidence of bias against faculty members in under-represented groups. This was later put on hold by the Faculty Chair and IPAR.
