The 2020-2021 UEC worked on developing webpage highlighting ECU's natural areas, and progress was made on this webpage since that time.

Under the direction of Chad Carwein, ECU's Sustainability Manager, ECU earned a Silver rating from The Sustainability Tracking, Assessment & Rating System (STARS) and was listed in the Princeton Review's Guide to Green Colleges for 2021 as one of the top 416 green campuses in the United States.

The committee supported and helped publicize the important work of Mr. Carwein, including the Sustainability Film Series, which continued on a virtual platform, and community-based initiatives such as the community garden.

ECU Natural Areas: Otter Creek site: Under Mr. Carwein's direction, the committee made major headway this year toward advancing the possible future use of this site by faculty and students. Committee members toured the site, and Mr. Carwein investigated the mapping of the site's boundaries and led student volunteers to mark the boundaries and do some initial trail-marking and clearing. The committee discussed a possible future reopening ceremony for the site.

Recycling: The committee received updates from Terry Little, ECU Recycling Coordinator, and asked questions about changes in recycling rules. A particular concern was raised about the change in Pitt County's recycling that will no longer accept glass. The committee discussed possible solutions and educated ourselves about the current situation.

Confetti: The committee continued to proactively address the problem of with confetti strewn on campus for graduation photos and celebration, which came to the committee's attention during AY 2019-2020. Chad Carwein launched a social-media campaign and worked with faculty and students to promote alternatives to confetti, such as blowing bubbles, making biodegradable confetti, or using telephone filters. This included tabling initiatives at the ECU Student Center. The committee contributed ideas, helped spread the word, and supported this campaign. Given that the confetti problem continued, we recommend that this campaign continue, beginning mid-fall semester at the latest, for AY 2021-2022.

The committee proposed two resolutions to ECU Faculty Senate, which passed:

- 1. **Resolution on Beverage Contract:** The resolution would have charged the company under consideration, Coca Cola, to commit to reducing single-use plastics on campus. However, Interim Chancellor Ron Mitchelson did not approve this resolution when it reached his desk.
- 2. Resolution to Support ECU Honors Students Regarding Tobacco Use on Campus: The Resolution, also approved by the SGA, supports students working amend North Carolina General Statute Chapter 143 Article 64 Parts 596 and 597 to give UNC system campuses local autonomy to declare a campus to be tobacco-free or to change the range of required tobacco-free space surrounding campus buildings. The Chancellor signed this resolution. The committee has continued to support this bill, which was making its way through the legislative process as of May 2021.

Buildings and Sustainability: The committee had a productive meeting with John Gill, Assistant Director of Facilities Services Grounds Services – Landscape Architect, ECU. We submitted requests that new buildings and renovations of existing buildings take sustainability into account, including storm-water runoff and green roofs, etc. Mr. Gill was very supportive and answered questions. He shared a landscape architectural drawing of a green space in the Brewster Building courtyard, but there are no funds for this.

Building health: The committee discussed the need for faculty and staff to understand the mechanisms for reporting any concerns about building health and risks to employee health. Bill Koch educated the committee about his department's work, and the committee plans to work on a communique or guide to help employees nagivate the process.

Divestment from Fossil Fuels: In the committee's final meeting of the year, we met with Chris Dyba, Vice Chancellor for University Advancement, to learn about university investments, and the potential for disinvesting those resources from fossil-fuel-based companies. We learned that divestment campaigns have become mainstreamed and that environmental sustainability investments are considered to be more profitable and secure. There are already advising companies that lay out divestment plans, and we were encouraged that ECU may be open to this. We will return to this question in Fall 2021.
