Subcommittees established during the year (include progress and/or completion of work).

The UCC established a subcommittee to review and provide feeback to the proposed Prior Learning Assessment (PLA) Policies and Portfolio-Based Assessment Procedures.

Accomplishments during the year. Please include recommendations made to any University agency <u>other than</u> the Faculty Senate.

- A. The UCC reviewed and provided feedback to the Admissions and Retention Policies Committee regarding the proposed 0-credit hour course policy. Having a specific policy in the credit-to-contact hours guidelines will assist faculty in course development and use of courses that do not have assigned grades. New proposals with 0-credit hour courses included specific language to demonstrate the relationship between the credit bearing course and the co-requisite 0-credit course.
- B. The UCC discussed and approved revisions to the "Significance of Course Numbers" catalog text. The revised text will ensure that 5000 level graduate courses can not be required in an undergraduate degree, but can be included as an elective option.
- C. As part of SACSCOC reaccreditation efforts, the UCC was informed that structured concentrations in the Multidisciplinary Studies, BS and BA needed to be editorially revised to include more details about existing degree requirements to ensure compliance with SACSCOC policies. The UCC discussed how the additional information for each concentration should be formatted in the catalog and if it was appropriate for a concentration to have its own page in the catalog. As a result of this conversation, the UCC determined that there are two instances when concentrations in a single degree can have more than one catalog page: 1) Degrees that have been identified by the UNC Board of Governors as not meeting productivity criteria and in need of being restructured or discontinued, 2) Degrees that do not require common core or cognate courses and offer concentrations that consist of a specified group of courses in a particular field or discipline that is typically interdisciplinary or multidisciplinary in nature.
- D. The UCC reviewed, discussed, and provided feedback to proposed policies and procedures for prior learning assessment, which seeks to develop procedures for the recognition and awarding of credit for equivalent extra-institutional learning processes through portfolio-based assessment. Feedback provided to faculty senate included questions about the proposal and the required courses for the portfolio.
- E. A UCC representative, Colleen Janerio, participated in the Alterantive Block Schedule (ABS) Strategic Enrollment Planning (SEP) Implementation Team, to offer feedback regarding the schedule process related to undergraduate curriculum.
- F. The UCC held an extra meeting to review and approve curriculum packages on April 7, 2022 to provide more units the opportunity to meet the deadline for inclusion in the 2022-2023 catalog.
- G. The UCC continued to utilize the comment feature in the proposal forms in Curriculog to alert originators to small errors/questions about proposals before the meetings. This practice allowed originators to address issues or answer questions before the meeting in many cases, and the meetings were more efficient and fruitful as a result.
- H. The UCC conducted all meetings during the 2021-2022 academic year through Teams, utilizing the waiting room, chat, and screen sharing features. The virtual format facilitated UCC members, including elected and ex-officio members and staff, to discuss packages with presenting faculty and guests regardless of their location and social distancing requirements.
