- Recreation and Wellness Advisory Council (Casey Fleming): The committee met monthly to update members on budgets and activities. Relevant for FWC is a proposed increase in membership fees for the 2022-2023 year to be discussed in the fall.
- University Budget Committee (Steve Wolf): The FWC representative was charged with
 working on three items relevant to the salary sub-committee: 1) Summer salary; 2) Need
 to put tenure & promotion raises in writing and establish mechanism for maintaining
 raises into the future; 3) Establish amount and mechanism for promotional raises for
 fixed-term faculty. This work is ongoing and will carry into 2022-2023.

- 5. Work with the Faculty Senate Officers in their review of faculty benefit packages to consider the addition of a patient advocate benefit.
