- Establish protocol to communicate with WI-by-section instructors / their chairs each semester
- Update WI checklist on WAC website
- Create tutorial for the UCC process to add ENGL 2201 as a co/pre-requisite
- Create / establish use of BIC report for WI review data
- Consider shifting responsibility for WI-by-contract courses to committee from the director the University Writing Program

EVALUATION OF THE COMMITTEE

- A. Charge: Committee fully met its charge working virtually.
- B. Personnel: The committee is composed of faculty from five colleges & one library and administrators of the University Writing Program and Writing Foundations. It worked out well that each college under review this year had a representative on the committee.
- C. Attendance: Quorum not met at 2/14/2022 meeting, and barely met on 11/8/2021 and 4/11/2022. The committee had two unfilled ex-officio seats (Faculty Senate Representative & Student Government Association Representative), and the committee chair requested removal of two regular members for non-attendance.
- D. Responsibilities: (See notes in italics)
 - 1. The committee promotes the University Writing Program and recommends policies and guidelines governing the development and offering of courses and seminars that are officially to be designated as writing-intensive courses.
 - 2. The committee reviews and approves proposals for writing-intensive courses, makes recommendations to the Faculty Senate regarding proposals carrying the writing intensive

- designation, and reports those recommendations to the University Curriculum Committee. *The committee has not sent recommendations to the UCC. It is the responsibility of the individual making the UCC proposal to show proof of WAC approval.*
- 3. The committee periodically reviews existing writing-intensive course offerings and recommends, as appropriate, changes to course writing-intensive status in order to ensure that standards for writing-intensive credit are being met.
- 4. The committee reviews the activities of the University Writing Program, advises the administrative leadership in that program, and serves as a liaison between the University Writing Program and the Faculty Senate. The committee hears resports at each meeting from the University Writing Program, but does not review the work of the UWP.
- 5. The committee reviews honors seminar proposals for writing intensive credit. *The committee has not reviewed Honors seminar syllabuses this year (or last).*
- 6. The chair or appointed representative serves as an ex-officio member of the Honors College Faculty Advisory Committee. *The vice-chair has served in this function.*
- E. Activities: The committee was actively engaged with all aspects of its charge.
