Nov. 1, 2022:

RESOLUTION #22-58

Professor Hvastkovs (Chemistry), Chair of the Committee, first presented proposed revisions to ECU Faculty Manual Part VI., Section I., Subsection X. Class attendance and Participation Regulations. The Committee first presented revisions to the Faculty Senate at the March 29, 2022 meeting. The Faculty Senate provided feedback and voted to send the revisions back for further consideration by the Committee. The Committee addressed the feedback from Faculty Senate in the proposed revisions. The revisions to ECU Faculty Manual Part VI., Section I., Subsection X. Class attendance and Participation Regulations were approved as presented.

RESOLUTION #22-59

Professor Hvastkovs then presented proposed revisions to University Undergraduate Catalog, Academic Regulations, Grading System, Grade Replacement Policy. The Committee proposed revisions to address a request from the Student Academic Appellate Committee for clarification of the policy in the catalog when applied to special topics courses, specifically if the topic is different in the second attempted course. There was no discussion and the revisions to University Undergraduate Catalog, Academic Regulations, Grading System, Grade Replacement Policy were approved as presented.

Dec 6, 2022

RESOLUTION #22-66

Professor Hvastkovs (Chemistry) presented proposed revisions to ECU Faculty Manual, Part VI., Section I., Subsection II. Office Hours. He noted that needs have changed since the policy was presented years ago to encourage student/faculty interaction. Due to recent changes they thought it was time to update the office hour requirements. There were no questions and the proposed revisions were approved by the Faculty Senate as submitted by general consent.

RESOLUTION #22-67

Professor Hvastkovs then went on to present Proposed revisions to ECU Faculty Manual Part VIII., Section I., Subsection II.A. Teaching Responsibilities. This revision is just to bring this area of the Faculty Manual in line with the changes that were just approved, which adds one line of text. There were no questions regarding the proposed revisions and the revision passed the Faculty Senate by general consent.

Feb 21, 2023

Professor Hvastkovs (Chemistry) presented proposed revisions to University Undergraduate Catalog, Academic Regulations, Attendance and Participation. He explained that the revisions were meant to align the catalog with revisions that were made to similar information in the ECU Faculty Manual. There was no discussion, and the proposed revisions to University Undergraduate Catalog, Academic Regulations, Attendance and Participation were approved as presented.

RESOLUTION #23-17

Professor Hvastkovs then presented proposed revisions to ECU Faculty Manual Part VI., Section I., Subsection X. Class Attendance and Participation Regulations. The Division of Student Affairs requested that the Committee consider additional revisions, and the Committee approved some of those. There was no discussion, and the proposed revisions to ECU Faculty Manual Part VI., Section I., Subsection X. Class Attendance and Participation Regulations were approved as submitted.

RESOLUTION #23-18

Professor Hvastkovs then presented proposed revisions to University Undergraduate Catalog, Academic Regulations, Admission and Readmission, Transfer Students. These revisions were made after the recommendation from the Writing Across the Curriculum Committee to remove the requirement, and the hope is that it would ease the way for transfer students to come in. Instead of requiring the course for prior to admission, they can enroll in the course when they come to ECU and take it here. There was no discussion, and the proposed revisions to University Undergraduate Catalog, Academic Regulations, Admission and Readmission, Transfer Students were approved as presented.

RESOLUTION #23-19

Professor Hvastkovs then presented proposed revisions to University Undergraduate Catalog, Admission and Readmission, Veterans and Children of Deceased and Disabled Veterans. He explained that although holistic review was already taking place for these prospective students, language in the catalog could be construed as barring that option, so they wanted to make it clear that this option was open to these students as well. There was no discussion, and the proposed revisions to University Undergraduate Catalog, Admission and Readmission, Veterans and Children of Deceased and Disabled Veterans were approved as presented.

April, 25 2023

Professor Hvastkovs (Chemistry), Chair of the Committee, presented an update on the status of revisions to East Carolina University Faculty Manual Part VI., Section II. Academic Integrity. He stated the academic integrity violations (AIV) policy that was approved by the Faculty Senate in 2022, had been held in the Chancellor's Office and that a special work group was convened to review the policy further. He, along with a representative from the Office of Student Rights and Responsibilities (OSSR) and Office of University Counsel formed the work group with a few other faculty. He said recommendations presented to the faculty on that special work group were to move the AIV policy from the Faculty Manual to the University Policies Manual and he discussed challenges presented from the OSSR Office. He stated that overall the current ECU AIV Policy aligns closely with other UNC System schools but said the OSSR indicated their need for more authority from the Chancellor. He discussed how the Chancellor's Office decided to make this policy an official PRR without additional faculty guidance or consent and feels this does not align with ECU's strong history of shared governance. He stated he is unsure how the faculty should respond to this loss of control of academic integrity matters but welcomes the Faculty Senate's input on how to move forward with a response. Fac Senate, after discussion, voted on the following statement, which was sent to the Chancellor:

Whereas, Academic integrity is the application of pertinent personal virtues, such as honesty, responsibility, authenticity, honor, and justice, to academic work. Academic integrity is a cornerstone value of the intellectual community at East Carolina University. Academic integrity is required for students to derive optimal benefit from their educational experience and their pursuit of knowledge. Violating the principle of academic integrity damages the reputation of the university and undermines its educational mission. Without the assurance of

integrity in academic work, including research, degrees from the university lose value; and the world beyond campus (graduate schools, employers, colleagues, neighbors, etc.) learns that it cannot trust credits, or a diploma earned at ECU. For these reasons, academic integrity is required of every ECU student. Whereas, The faculty responsibility for academic integrity matters, the education aspects surrounding academic integrity, and the handling of these steps as long as they are in compliance with UNC policies should be based on recommendations by the faculty, who know the facts of the matter, the students, the curriculum, instructional standards, and grading. Therefore be it resolved, that the Faculty Senate recommends retaining the Academic Integrity Policy in the East Carolina University Faculty Manual.
