Computer Policy Review Subcommittee:

A subcommittee was formed at the August 31, 2022 organizational meeting, to respond to the suggested edits by the Academic Council to be sent to the Chancellor's Office regarding the Computer Replacement / Retirement Policy. Jonathan Reid was nominated to Chair the subcommittee and accepted. Jamie Bloss, Wendy Creasey, Melinda Doty, and Imre Patyi served as members. The response was presented to the Committee at the February 22, 2023, meeting. There were no substantive changes made. It was presented to Faculty Senate on March 28, 2023.

Instructional Continuity Website Subcommittee:

A subcommittee was formed at the January 25, 2023 meeting, to review the Instructional Continuity Website led by Wendy Creasey; members include Vera Tabakova, Nancy Dias, Jennifer Baysden, and Ryan Bonnett. They will also be joined by Melinda Doty and Rachel Baker. The subcommittee met February 8, 2023. A vote to approve the changes to the Continuity Website was held at the February 22, 2023 meeting, and passed. It was presented to Faculty Senate on March 28, 2023 as information only.

Student Survey Subcommittee

A subcommittee was formed at the September 28, 2022 meeting, to be chaired by Jonathan Reid; members include Jennifer Baysden, Wendy Creasey, and Melinda Doty. The goal is to complete the survey in Fall 2023. The subcommittee believes the main things to be done in terms of design would seem to be: prioritize and select the most important topics, formulative the questions, and estimate how many questions could fit into a 10-minute survey. Next year, the committee will have to work on implementing it including having a survey expert review the design, get permission and have the appropriate authority administer it to the student population that is appropriate, interpret the results, and share the report of results with any recommendations to faculty and others as appropriate.

<u>November 1, 2022</u> * Professor Doty, Chair, presented an update on the proctoring pilot that began during the Fall 2022 semester. She stated the Proctoring Taskforce consists of eight faculty including two Distance Education and Learning Technology Committee members. Due to a court case involving ProctorU,full room scans have been eliminated and the need to offer alternatives has led the Taskforce to look into Smart Proctoring for the spring semester. Additional updates will be provided in the spring semester. The report was presented for information only.

<u>March 28, 2023</u>* Professor Doty, Chair, presented proposed revisions to East Carolina University Faculty Manual Part VI., Section III., subsection IV. Fostering Academic Integrity in Distance Education and associated resource document "Fostering Academic Integrity in Distance Education". The Committee wanted to provide sample syllabus language related to online proctoring and update some of the information related to academic integrity issues in distance education. This passed (Resolution #23-29).

<u>April 25, 2023</u> * Professor Doty, Chair, presented updates to the Instructional Continuity Site. The report was presented for information only.
