- Libraries and Fiscal Sustainability Initiative
 - The committee reiterated its support of the findings of the University Fiscal Sustainability Coordinating Committee Libraries Working Group report that was presented in 2021.
- Tenure track eligibility for library faculty
 - o Committee communicated with library faculty who voted to pursue investigation
 - Lewis and Ketterman spoke with HR to find out about process.
 - Based on information from that meeting, library faculty voted against committee recommending tenure track eligibility to Faculty Governance Committee.

September 21, 2022 -

Appointment of Regular Members to Serve: Helen Dixon to serve on the Open Access
 Publishing Support Fund and Scholarly Communications Committee (with Shannon Powell as
 alternate for the Scholarly Communications Committee) and Kawanna Bright as liaison to the
 Special Collections Committee.

October 19th, 2022

- Brandon Stilley, Interim Head of the Music Library gave an overview of the services and activities of the Music Library
- Discussion of tenure-track library faculty positions occurred including history of how this item
 came to the library committee for review. After committee members shared points of view, it
 was suggested to first have meetings with ECU librarians to discuss how much demand is on
 their part for tenure-track eligibility of librarians, either in separate meetings for the library
 branches or together.

November 16th, 2022 -

- Jamie Bloss, Liaison Librarian to the School of Dental Medicine and the College of Allied Health Sciences presented on the duties of liaison librarians at Laupus Health Sciences Library.
- Discussed tenure-track positions for library faculty positions including concerns and benefits shared from library faculty associated with the differences between fixed term and tenure-track options. Planned further discussion for spring semester.

January 18, 2023 -

- Research Librarian Kerry Sewell from the Laupus Library presented on the Roles and Responsibilities of Research Librarians.
- Discussion of tenure-track library faculty positions continued. Corey Harmon reported to the committee that ALS faculty and staff met in December and voted in favor of further investigating the possibility of tenure-track positions for library faculty. Based on the feedback, Jan Lewis and Beth Ketterman agreed to meet with Wendy Sergeant from HR to explore what moving towards tenure-track positions for librarians would mean in practical terms and whether that was even feasible. Kawanna Bright, Jaime Bloss, and Corey Harmon volunteered to start the process of getting more information from other NC System institutions about their processes.
- Kawanna Bright announced a bid for a library research seminar that would likely take place at ECU in October 2024.

February 15, 2023 –

- Erin Gray, Technology Manager presented on main campus library circulating equipment.
- Discussion of tenure-track library faculty positions continued with follow up from previous meeting. Based on the findings since previous meeting, the committee decided to take the following actions:
 - Take the issue back to the libraries and have a vote before the next committee meeting in order to determine whether librarians want to pursue the matter, given the new information that has become available.
 - If librarians vote in favor, then the committee can make a recommendation to Faculty
 Governance Committee to consider the issue further. If librarians vote against it, then no
 further action needs to be taken by the committee.

- Discussion of tenure-track library faculty positions continued with follow up from previous meeting.
 - Library faculty in both ALS and Laupus Library voted against moving forward with reinstatement of tenure. Libraries Committee will not make a recommendation to Faculty Governance Committee.
