Research Conduct Policy: Amanda Haberstroh and Uduak Akpan

The Committee was charged with reviewing a revised version of this regulation (originally titled “Regulation on Research Conduct”), which appears below. The Committee has been made aware of concerns that persist in the revised version and members have been meeting with several campus offices to gather more information. These meetings are ongoing, and more work needs to be done before the Committee’s formal advice is finalized. The committee will clarify the process for this policy and the intersection with other polices. The full formal faculty advice will be presented at a meeting during the 2022-2023 academic year.

The year began with review of the FSRA award. There were 14 applications which split nicely across three broad area, STEM (5), Humanities (4), and Health Sciences (5). Two awards from each area were recommended as well as 3 at large award recommendation. Amanda Haberstroh was appointed to serve on the Committee on Copyrights. The committee charge was revised to reflect changes in institutional structure, the Faculty Support and Resignment Awards, and the Research Intensive Designation.
