Agenda Item: Approval of the minutes of the January meeting

Agenda Item: Grade forgiveness and replacement policy

<u>Discussion:</u> Angela Anderson and Steven Asby described to the committee the proposed changes to the grade forgiveness and replacement policy. The proposed forgiveness policy will allow the University to automatically apply the forgiveness of failing grades to those returning students who qualify for it. The proposed grade replacement policy allows the students to use a grade replacement a maximum of four times in any class the student wishes to replace the grade. The policy acts retroactively for all students completing degree requirements in catalogs which have not yet expired. The committee suggested to replace all instances of the word "granted" to "applied" in the revised policy documents.

<u>Action Taken:</u> David Hisle moved to approve the Grade forgiveness and replacement policy as presented. Eli Hvastkovs seconded. The motion was unanimously approved.

Agenda Item: Discussion about the office hours policy in the faculty manual

<u>Discussion:</u> The committee discussed the issue of updating the current office hours policy. The committee suggested that faculty members should the flexibility to hold office hours both in an on-campus and/or virtual location. The committee discussed if the current minimum required number of office hours should be reflecting the teaching load of an individual faculty member.
