- 7. 2:25 Discussion of use of SSOI scored during the pandemic. The committee discussed the potential impact of moving courses online on SSOI scores. During the discussion, a recent case of racial bias impacting the SSOI scores was described. A minority instructor was given low SSOI scores because the instructor gave their students a term-paper assignment. Although we are not working on this issue at the moment, bias against minorities is part of our larger concern with the use of the SSOI. The committee does not know how many instructors are being negatively impacted by moving classes online. The committee discussed various possible actions. Since the fall 2020 SSOI results already are distributed to instructors, options for fall include not using the fall results in this year's annual evaluation, making the use of the fall results optional (each faculty member can indicate whether their SSOI results will be used in their annual evaluation), or use the results with a reminder to evaluators to follow the instructions in the Faculty Manual for evaluating teaching and for the role played by the SSOI in the evaluation of teaching. The committee raise analogous points about the winter results. For the spring 2021 SSOi, questions included whether to distribute the results to instructors only or to instructors and administrators. The other options considered for fall 2020 were also considered for winter and spring 2021. No conclusions were reached. Two questions were raised: how many students should be the minimum number of students in a class for the class to be surveyed? and what percentage of students in a class must do the survey for the scores to be reported (or used)? IPAR will investigate by class level.
- 8. 2:40 Dr. Kristen Dreyfus discussed the procedures that would be used by committee members to learn how to review general education humanities syllabi. We will finalize our collection of syllabi. We will collect feedback on the rubric and determine if any changes are needed.
