III. Discussion and Approval of Revisions to Format for University Academic Calendars

- a. Statements in calendar format, "Last day for faculty to remove incompletes in graduate and undergraduate courses...," were reviewed and approved.
- b. Election Day in fall and Primary Election Day in spring

Discussed various options to present the Election Day and Primary Election Day in the Spring. Committee agreed that Primary Election Day would not be included in the Spring Session since this does not occur every year.

c. New format for Academic-Year Calendars ("skeleton")

Decided to publish the "skeleton" format three years ahead. The Summer Session formats were presented and suggestions were made not to include the weekday for the July 4th state holiday.

Changes will be made. The Fall, Spring, and Summer formats presented were approved with the changes in the Summer.

d. Alternative solutions for late Thanksgiving

Discussed the various options as noted on the 2019 University Academic Calendars Format (Revisions). Options included class cancellations presented at different times in the Fall Session and adding a 15th Tuesday.

- The motion made is not to cancel Tuesday classes as a solution to the late Thanksgiving in the Fall. Mark McCarthy seconded the motion.
 Discussion revealed concerns that a cancellation would create more confusion through many divisions and classes with the cancellation of select groups/classes. All were in favor.
- ii. The motion made is to add a 15th Tuesday when the calendar presents with Thanksgiving falling late in the calendar. Mark McCarthy seconded. The committee agreed by majority rule.
- iii. The committee agreed that night classes could be cancelled on the Tuesday before Thanksgiving when Thanksgiving falls late.
