Agenda item: Review DELT Committee Charge

**Discussion:** revisions from the committee are summarized. Main changes included making the Director of Digital Learning a regular member and the Chief Information Officer (or appointee) as ex-officio. Language is added to address best practices are followed with online learning. The committee offers advice to faculty, reviews annually the DE modules and contingency plan information on the website, adds request for a committee member to serve on any task force or advisory group that address technology, and the chair of the committee serves as a liaison to the university leadership (Faculty Senate, CIO, Provost, etc.)

Action: Committee recommends the changes with a minor edit to name the Director of Digital Learning as the regular member (delete Emerging Technology Initiatives)

Agenda item: Diversity, Equity, and Inclusion (DEI) Charge

**Discussion:** Crystal Chambers and Amanda Klein will present at November meeting. Prof. Martinez shared that recommendations for diverse representation to be sent to the committees. Some talk about creating a Faculty Senate Diversity, Equity and Inclusion Committee. This decision starts with the CoC (new committee creation).
