Revision of Existing Minor (**Level I**)

#### Aerospace Studies Minor

- Dr. Lebeck introduced himself and summarized his proposal.
- Discussion of proposal.
  - From Dr. Lebeck's attached pdf pasted in new Justification: Aerospace studies minor is reducing required credits to encourage participating cadets to complete the Aerospace minor. However, due to current credit requirements, students were not able to complete the additional coursework in the required timeframe. This minor is open to all students and 18 credits is more in line with other ECU minors. The currently published Aerospace studies minor in the course catalog requires 15 semester hours of cognates that are general education courses not related to the field of Aerospace studies. Students will receive the information provided by these cognate electives required by their specific major course of study. Additionally, the Aerospace minor is expanding its required courses to include 1000- and 2000-level as well as the previously required 3000- and 4000-level

AERO lecture courses. In doing this, the Aerospace minor will encapsulate all Aerospace topics into one complete course of study. Finally, to ensure that the Aerospace minor is available to all students and not just AFROTC cadets, KINE 1000 level courses are available as a substitute for the two semester hours of AERO Labs. Due to legal requirements AERO labs are only available to active AFROTC cadets.

- From Dr. Lebeck's attached pdf added change to #9 in the SOR: 2 s.h. of AERO labs and/or KINE 1000 level activity courses to meet the minimum requirement of 18 s.h.”
