<u>DISCUSSION</u>: This opportunity presented itself at a time when the department was considering ways to expand enrollment. Everyone involved approved for a variety of reasons, not the least of which is that it is in line with ECU's commitment to assist those serving in the military. The underlying question from EPPC centered on why the physical presence was an important component. First nine courses are offered on base, then goes to online. Would begin with a presence at Cherry Point. Allows us to have a presence in the Triangle as well -- the BSIT could be delivered there using Wake Tech facilities. New faculty line and new staff member would be needed – can department do this without them? No, but the effort to keep a physical presence on bases is a broader mandate, so would depend on ECU administration for support. All the commitments made prior to COVID are meaningless now, but Dr. Mohammed emphasizes that preparing for this was what was asked of the department, and it has been accomplished. The department does offer the BSIT online already - students can already do this without a base presence. But this is a strategic enrollment priority and the sense is that the money would be there. Once BSIT is there other ECU departments can also use/share the space on base(s).

DISCUSSION: Kain was the EPPC rep for this. External Review Team said the curriculum needed modernizing. Department will do that in the Fall retreat. There is a required capstone 6-week field course – the External Team noted the financial and time burden this represents. Suggested Department looks for alternative ways to teach that course. Department's concern is that most geological programs around the country require this. The possibility was noted that in the capstone some field work can be done in the Eastern United States. However, getting reasonable accommodations at the coast is problematic. Department is doing a virtual course this summer of necessity due to COVID-19 but alumni speak highly of the physcial field course. This will be discussed at the Fall retreat.

External Team recognized need for new tenure track faculty members in the department. Due to transfers to administrative work, other transfers, and retirements the department is down from 15 to 9 tenure track faculty.

Program Revision – BS Computer Science

Program Revision – EdS Educational Administration and Supervision

DISCUSSION:

Program revisions were mandated to meet the January 2008 standards promulgated by the North Carolina Department of Public Instruction (NCDPI) for educational leadership programs leading to the superintendent license. As stipulated in those standards, the licensure process focuses on outcomes, rather than inputs. All Educational Leadership programs in the North Carolina University System were required to submit blueprints of licensure programs that demonstrated candidate on-the-job performance and institutional involvement with and service to the public schools.

The Department of Educational Leadership faculty have worked to revise the program to meet our NCDPI-approved blueprint (submitted and approved in 2014) and have devised assignments to align with the January 2008 superintendent licensing requirements.

Revisions were detailed in the memorandum presented.

Additionally, these revisions will set the program on a path to obtaining national accreditation from the National Policy Board for Educational Administration (NPBEA)."

New Graduate Certificate - Digital Learning for Educational Leaders

Unit: Mathematics Education, Science Education, and Instructional Technology.

DISCUSSION:

Since Fall 2017, the NC Department of Educational Leadership Department of Public Instruction's Digital Teaching and Learning Division has been implementing the Digital Learning Competencies (DLCs) for school administrators and teachers.

Based on the survey data recently collected with NC classroom educators, school administrators, and higher education faculty, the department has identified a gap in practice. School administrators feel they are unprepared to adequately evaluate teachers on the implementation of the DLCs into the classroom. Therefore, faculty in Instructional Technology in conjunction with the chair of the Department of Educational course to support school administrators to understand the DLCs and identify best Leadership determined the need for creating a 12-credit hour certificate and one new practices modeling and assessing classroom teachers implementing the digital competencies. The Instructional Technology program faculty identified the following existing courses for the certificate:

EDTC 6070: Digital Literacy for 21st Century Classrooms

EDTC 6149: Planning and Administration of School Technology Programs

EDTC 7035: Designing K-12 PD for Delivery in Online and Blended Learning Environments

EDTC 7303: Special Topics in IT: Digital Learning for Educators

Also identified a new course is needed to expand offerings in digital learning competencies for educational leaders.

EDTC 7100: Educational Leadership and Technology

The Instructional Technology faculty voted and approved the Digital Learning Certificate on November 17, 2018. The Digital Learning Certificate was presented to the Department of Mathematics, Science, and Instructional Technology Education (MSITE) faculty and approved on March 15, 2019. The faculty of the Department of Mathematics, Science, and Instructional Technology Education voted and approved the changes made for the Digital Learning for Educational leaders certificate and the EDTC7100 course on January 22, 2020."
