AGENDA ITEM #2: Final Approval of Proposed Revisions to the APR Guidelines

<u>DISCUSSION</u>: The only new addition from our last EPPC meeting is some inclusion of diversity language. Collins suggested a change – on p. 2 it has the old language. Section One should Match Section Six. Towards end – McConnell saw three places where the word unit is used – should that still be the case?

DISCUSSION: Document shared by Jean-Luc from Sharepoint. Bowler had made some suggestions via email. Looked at suggested changes to present catalog language, minor requirements. Bonner appreciates the complexity but points out that the catalog language seems to be for a BA degree. For a Criminal Justice Minor it doesn't work to insist the student take the minor completely outside the major – thereby excluding courses like forensic lab work. Jean-Luc offered several reasons that catalog language needs to be clearer. Jenks raised several questions. Difference between concentrations and minors -- concentrations require students to major in that area. How many credits are too many? Rachel Baker was able to address several points raised.

As is evident in the discussion above, there is still much to come to terms with in this. No decisions taken today. But what happens next time? Bellacero reminds that we have essentially the same discussion each time we discuss this. Collins will talk to Bowler further.

<u>DISCUSSION</u>: Eases financial burden for students. Kept courses that allow students to sit for accreditation.. Nine hours is minimum. Question raised: Can you cover in nine what you covered in twelve? Yes -- eliminated an elective.

<u>DISCUSSION</u>: Have been discussing for some years. Conducted surveys that have shown a student demand for this. Working adults, veterans are the target market. Only one other UNC school – UNC Wilmington -- offers grad instruction in history in NC. UNCW program is targeted to history educators. To go online within five years – questions about why it needs to take that long to begin offering. Faculty resources are still an issue, have to balance an undergrad program as well.
