Informational Updates

Project Kitty Hawk

Aims at adult learners and/or working professionals looking to acquire credentials and/or a degree to advance. Marketing is targeted to part-way home students, workplaces, and not high school students. ECU will approve the faculty and the curriculum for a degree that someone may acquire through ECU and Project Kitty Hawk. It is possible that ECU faculty would teach ECU classes and classes through Project Kitty Hawk. Faculty teaching PKH classes will be predominately fixed-term faculty and part-time temporary faculty. Enrollment standards should be approximately the same for Project Kitty Hawk as the institution serving the student. Courses will be delivered online asynchronously and offered in blocks. There would be at most three programs offered for a single degree. Every department should have veto power over offering a degree/classes through Project Kitty Hawk. ECU will receive some financial benefit from this partnership; however, credit hours from PKH will not count toward UNC GA allocations.

Students should be able to take courses through Project Kitty Hawk and ECU. Students will be required to complete General Education courses if they are completing a degree program. After 5 years, a department can decide to opt out of the project.
