In response to a program review, the Department of Biology proposed changes to the core curriculum to reflect the interdisciplinary nature of the program. The proposed changes to the core curriculum will offer foundation courses focused on research skills and tools. Courses that offer the depth of disciplinary content will count toward a trainee's concentration electives (biology, biomedicine, or chemistry). The Department updated the list of courses that fall under statistics/experimental design. This updated list of courses will replace the current list of courses, which has not been updated in over 10 years. This course list update will represent currently offered and cuttingedge course offerings that provide BBC graduate students the option to take courses most relevant to their research interests and training needs. The updated core requirement of 'cross-cutting skills/tools' will provide the opportunity for BBC graduate students to take courses that expand their research toolkits.
