a. Report from Reide Corbett, Director Coastal Studies Institute, Dean Integrated Coastal Programs

Discussion:

a. Reide Corbett introduces the ECU Integrated Coastal Institute and the Outer Banks Campus located in Wanchese and overlooks the Croatan Sound. There are no dorms on the campus currently. It opened in 2013. The campus has storm water retention ponds and collects roof water for recycling, which is used in the toliets. A significant portion of the property is wetland. There is about a 3-10 foot per year eroding shoreline along the sound. They have instead four 100-foot long sills to reduce energy to slow down erosion without impacting the wetlands. In 2018, the Integrated Coastal programs was established and with this, the department of Coastal Studies within the Coastal Studies Institute. It is a multi-institutional research partmership with other UNC System schools, but lead by ECU. They have multi-research focused areas that are interdispinary. The institute is part of the NC Renewable Ocean Energy Program, which is about a 2 million dollar/year funded program and includes other UNC system universities. Currently they are hosting Waves to Water program. focusing on using wave energy to covert salt water to fresh water. Interested in partering with faculty to teach semester long classes face to face, possibly Friday and Monday classes. Open house late May 2022 possibly.
