First reading of proposed revisions to the Service-Learning Committee Charge

The Committee on Committees proposes the following changes to the Service-Learning Committee charge:

Additions in **bold** and deletions in strikethrough.

East Carolina University Faculty Senate SERVICE-LEARNING COMMITTEE CHARGE

Faculty Senate Resolution #22-42, May 2022

- 1. Name: Service-Learning Committee
- 2. Membership:

The committee membership, including ex-officio members, should encompass a wide variety of disciplinary expertise.

9 elected faculty members

Ex-officio members (with vote): The Chancellor or an appointed representative; 3 Provost appointed representatives, 1 with academic or administrative expertise in Health Sciences disciplines, 1 with academic or administrative expertise in Research, Economic Development and Engagement; the Chair of the Faculty or an appointed representative; one Faculty Senator selected by the Chair of the Faculty; the one student member from the Student Government Association; and one member from the Graduate and Professional Student Senate.

Ex-officio (without vote): The administrative leader of the Center for Leadership and Civic Engagement or an appointed representative.

The chair of the committee may invite resource persons as necessary to realize the committee charge. The chair of the committee may appoint such subcommittees as he or she deems necessary.

- Quorum: 5 elected members exclusive of ex-officio.
- 4. Committee Responsibilities:
 - A. The committee makes recommendations to the Faculty Senate regarding proposed changes in the service-learning requirements and regarding the service-learning

- designation for individual courses. The committee makes recommendations to the Faculty Senate regarding individual courses carrying the service-learning designation. and It reports these recommendations to the Undergraduate Curriculum Committee and the Graduate Curriculum Committee.
- B. The committee reviews existing service-learning courses periodically and recommends, as appropriate, changes to course service-learning contents and/or status to ensure that Student Learning Outcomes for the service-learning curriculum are being met.
- B. C. The committee serves as a liaison between the Faculty Senate and the Center for Leadership and Civic Engagement. In reviewing curricular and other academic matters related to service-learning, it consults with and advises the administrative leadership of the and the Faculty Senate, reviews the activities of the Center regarding these curricular and academic matters. for Leadership and Civic Engagement and advises the administrative leadership of that center about service-learning.
- C.D. The Committee reviews at least annually those sections within the *University Undergraduate Catalog* and *University Graduate Catalog* that correspond to the Committee's charge and recommends changes as necessary.
- D.E. The committee promotes and advocates for service-learning across the curriculum. It assesses SL learning outcomes and matters related to the development of service-learning SL courses.
- E.F. The committee reviews honors seminar proposals for service-learning credit.
- F.G. The committee requests reports from IPAR in fall and spring semesters to locate and recognize undergraduate and graduate students who have earned an SL certificate by completing at least three SL-designated courses at ECU with a "C" or higher grade. It awards an SL certificate to students and informs them of the option to purchase a silver-and-white honor cord.
- H. The Chair represents the SL Committee in monthly Faculty Senate Committee Chairs meetings.
- I. The chair or An appointed representative serves as an ex-officio member of the Honors College Faculty Advisory Committee.
- J. An appointed representative serves on a subcommittee of the Academic Awards Committee to review and select a recipient of the University Service-Learning Teaching Excellence Award.
- 5. To Whom The Committee Reports:
 - The committee reports to the Faculty Senate its recommendations of policies, procedures, and criteria cited in 4, above. The committee recommends curricular changes to the university's service-learning requirement to the Faculty Senate.
- 6. How Often The Committee Reports:

 The committee reports to the Faculty Senate at least once a year and at other times as necessary.
- 7. Power Of The Committee To Act Without Faculty Senate Approval:
 The committee is empowered to advise the Center for Leadership and Civic Engagement as described in 4.B. above.
- 8. Standard Meeting Time:
 The committee meeting time is scheduled for the second Tuesday of each month.
