

# 2020-2021 FACULTY SENATE ORGANIZATIONAL MEETING

The organizational meeting of the 2020-2021 Faculty Senate was held on **Tuesday, May 5, 2020,** at 2:10 p.m. as a virtual meeting, using WebEx.

## I. Call to Order

Professor Jeff Popke (Geography, Planning and Environment) Chair of the Faculty called the meeting to order at 2:10 p.m.

## II. Roll Call

Senators absent were: Professor Wolf (Physics)

Alternates present were: Professors Stacey for Brewer (Criminal Justice), and DiMartino for Ivany (Music).

### **Announcements**

Chair Popke welcomed the new members of Faculty Senate: Linda Quick (Business), Steven Brewer, Jr. (Criminal Justice), Brian Miller (Engineering and Technology), Page Varnell (Engineering and Technology), Eduardo Leorri (Geological Sciences), Amanda Haberstroh (Health Sciences Library), Paul Bolin (Medicine), Thompson Forbes (Medicine), Beng Fuh (Medicine), and Richard Miller (Philosophy and Religious Studies).

Chair Popke referenced materials that were sent by email to the Senators on April 29<sup>th</sup>, which included links to the Senate roster, Senate FAQ, and the parliamentary motions guide. He reminded everyone that the Senate operates according to Robert's Rules and parliamentary procedure. After summarizing Senate procedures, Chair Popke welcomed Interim Chancellor Mitchelson to the meeting, who was invited to address concerns and answer questions about the move to change the calendar for the 2020-2021 academic year from two 15-week blocks to four 8-week blocks.

# III. Ron Mitchelson, Interim Chancellor

Interim Chancellor Mitchelson thanked everyone. He began by discussing the development of an ECU Public Health Plan organized around eight teams led by campus administrators:

- 1. Calendar Team Grant Hayes
- 2. Experiential Learning Team Michael Van Scott
- 3. COVID Testing Group Mark Stacy
- 4. COVID-19 Tracing Group Mark Stacy
- 5. Facility Use Group Virginia Hardy, Grant Hayes
- 6. External Engagement Group Chris Dyba, Jon Gilbert
- 7. PPE Planning Workgroup Sara Thorndike
- 8. HR Issues and Risk Management Sara Thorndike, Paul Zigas

Interim Chancellor Mitchelson went on to say that much of what we have done has been influenced, orchestrated, and guided by the UNC System. That process of guidance is ongoing. He was on a phone call yesterday with President Roper and will be on the phone with him again on Friday. The UNC System has issued a guidance document in planning for reopening campus in the fall that has 44 bulleted items. The System would like to know where ECU would like guidance, so they are going to go through the 44 bulleted items. Some of this is to coordinate with other campuses and make sure the System understands the preferences and intentions of the campuses. Interim Chancellor Mitchelson said that process to get through all the bullets and coordinate with other campuses and the System will probably take a month, so some of the answers that faculty want today will not come until early June. The UNC System will have a voice over the occupation of the residence halls, they will engage in the purchasing of the cleaning agents and PPE.

Interim Chancellor Mitchelson noted that the Calendar item is an interesting one. He said that as a system, there is tremendous variation and thoughts about how the calendars should be structured. For example, Charlotte is driven by a peak in COVID-19 activity that will probably occur in July. They are thinking about moving away from the peak, and starting significantly later, after Labor Day, and having exams and commencement in January. NC State and Chapel Hill are thinking about starting earlier, as early as the first week in August. He said that the variation is to be expected, due to the uncertainty about the virus. He related that one campus in the system is thinking about implementing 1-month (4-week) blocks to provide the flexibility they believe is necessary to work under such uncertain conditions. He said he has also heard about other colleges and universities in the southeast that are headed toward the block scheduling. He understands that there are lots of questions about block scheduling, and he would like to create some certainty within the great uncertainty. He would like to come back to campus in late August, but some things have to be in place.

Interim Chancellor Mitchelson acknowledged that coming back in late August requires some imposition on freedom right now, and that imposition might be multidimensional by the end of it (impositions from the UNC System, the state, etc.). He said moving toward a block scheduling approach is not going to be easy but he pointed out that many faculty have done similar things. He said he taught on a quarter system for 13 years, and he thought the higher frequency of engagement with the students was superior and got better results than when he moved to a semester system. He said the empirical evidence is a bit mixed, but the literature he has recently read suggests that a higher frequency of interaction between faculty and students really does result in better outcomes for students. Nothing suggests this is damaging for student outcomes.

Interim Chancellor Mitchelson said that Jeff Popke and a group of faculty will work very closely with the Calendar Team and the Facility Use Group to make sure the blocks are implemented as best as they can. He said that he knows there is a desire to have some level of freedom or the ability to make exceptions, and that is now under consideration. He said he does not have the specifics about what can be excepted, but he anticipates that some things like experiential learning and internships might have to extend past the 8-week blocks. They are considering what circumstances would merit exceptions. They do not want to open the floodgate.

Interim Chancellor Mitchelson stated that the number one advantage provided by the block approach is flexibility. He really thinks it will be difficult to anticipate the revisiting of COVID-19 to North Carolina, so being somewhat nimble is better. It is very likely it will revisit within a 15-week period, but less likely within an 8-week period. He thinks places like Charlotte, will find it difficult to start as late as they plan. He knows faculty have a lot of questions and he will not be able to answer all of them.

#### **Questions**

Professor Thomas (English) asked which faculty did the administration consult when deciding on introducing the 7.5 week block scheduling.

Interim Chancellor Mitchelson answered that he would have to take the heat on this. He thinks this particular structure allows for us to open in the fall. He doesn't want to blame anyone, and if the inference is that there was a lack of process, we will certainly be more process-oriented as we move forward.

Professor Grodner (Economics) had some discussion with faculty in his unit, and there are questions about how willing students may be to enter rental agreements for housing when they have one 8-week block that is in person and perhaps another that is online. Would it create a disruption in students signing up for rental contracts, such that they would decide not to sign up at all?

Interim Chancellor Mitchelson replied that the uncertainty Professor Grodner is asking about would be there whether we had the blocks or not. The intent is for students to come back to campus and participate in face-to-face classes and activities and so they would probably make the normal sorts of decisions about housing. The students and their families understand that there will be some uncertainty. In terms of on-campus housing, that will be billed in an 8-week block format, precisely to benefit the student and the institution.

Professor Bauer (English) noted that in conversations with colleagues about changing the schedule in this way it is clear there are a lot of complications. There are so many moving parts and it is very close to the early June deadline of getting registration set up. She said she does not understand how the block schedule is more flexible. It seemed to her that the easiest way to proceed was for faculty with face-to-face classes to plan for the possibility or likelihood that they would have to go online like they did this spring, but this time they would be prepared. Then the focus would be on spreading out for safety, rather than starting from scratch. She said that her colleagues are also curious about the cost benefits for the block schedule, especially in contrast to the financial costs of maintaining a regular semester while planning to shift online as necessary.

Interim Chancellor Mitchelson replied that with block scheduling, we can bill appropriately. If we are going to bring students back for an 8-week block, we can bill under what we would regard normal circumstances. He said that if we repeat the history of what we had this spring semester, it is a financial disaster. There is a class action suit against the UNC system in this regard. Breaking classes up into 8-week blocks provides increased frequency of contact with the student and better learning outcomes, and also permits a much better and tightly aligned billing sequence that could benefit the institution. He really is trying to protect this institution in a period of time when it is risky and jobs are at stake. He thinks we are in a better position to protect jobs with this block approach than we are trying to start it face-to-face and finish it DE (distance education).

Professor Doty (Engineering and Technology) asked for elaboration on how the block scheduling would work and referenced the Interim Chancellor's previous statements suggesting two or three courses per block. She also asked for whether the Calendar Team had considered how they would be able to appropriately social distance and what that meant in relation to class size.

Interim Chancellor Mitchelson said the student load is determined by the goal of having students finish on time, which requires approximately 15 hours per semester. That translates into a 2/3 or 3/2 course load over the blocks. In similar fashion, faculty loads should be the same as they are now. With regard to social distancing, he thinks this can be operationalized in a certain way. A six-foot

buffer requires approximately 113 square feet per person. For the class he taught in one of the rooms in Brewster, that measurement would effectively cut the capacity in half. There are other options, like having half of the class come in face-to-face and alternate it. It will not be easy to work these things out. If a faculty member's course load is five courses, that remains the same for the academic year. As long as the student needs are being met, almost any configuration of faculty loads can be done. Other institutions have 8-week schedules and we have it on a smaller scale in some programs here, so it is not entirely new.

Professor Schinasi (Foreign Languages and Literatures) read an email to provide an idea of some of the sentiment of his department. It is from the view of teaching foreign languages. The email's author said that the 8-week block system was asking everyone to teach language intensively, and to make it work would require smaller classes and even with smaller class sizes students with difficulties are not going to do well. The email's author said that even though there may be a benefit to a student having only two or three courses at a time, it still cuts the number of study days in half. The email's author also noted that the virus will not adhere to a strict 8-week block of time, and it is going to hit when it hits and then faculty would presumably have to move back online. The author noted that being online in an intensive block schedule will kill students and that for classes with papers, for students who work, for students who take courses online from institutions in other states and multiple universities, this isn't going to work.

Interim Chancellor Mitchelson replied that those are valid feelings, but that in going back to evidence he has seen, increased frequency has better outcomes for students.

Professor Ticknor (Education) said she was exhausted, and imagines the Interim Chancellor is as well, and wondered about fatigue. She wonders how fatigue will impact students, faculty, and staff, no matter what is done in the fall. How will we get in front of that fatigue in a way that boosts morale, encourages safety, and encourages social distancing?

Interim Chancellor Mitchelson expressed appreciation for Professor Ticknor's empathy for everyone. He has never witnessed anything like this situation and admits that he is tired. He hopes that knowing we would employ 8-week blocks allows us to smooth out some of the preparation that is necessary. If he were teaching in the fall then he would employ a face-to-face component and an online portion. He doesn't know precisely what the solutions are going to be for morale. He said this is a real issue for everyone. He noted that there will be a new group of students coming in the fall and he knows that faculty are so committed to the success of those students. Maybe there will be some relief that the state or UNC system will provide, but the reality is that the state's coffers are suffering and will be for some time. He is not confident that relief will come from those sources. He will try to make sure he continues to express his thanks to faculty for doing this. He thinks block scheduling can be done successfully and has tremendous confidence that they will do it and do it well.

Professor McKinnon (History) notes there are lots of economic considerations involved in this move to an 8-week block schedule, and it seems like registration will have to be redone in order to change student schedules from a 15-week schedule to an 8-week schedule. Are we worried about losing students who will not re-register? How is that process taking place, what will prevent students from dropping off the radar?

Interim Chancellor Mitchelson said we will use the same mechanisms we use every semester. We will provide the kind of attention and contact that we regularly give students who are eligible to register and drop off the radar. There are trade-offs. Things we are doing because there is some level of certainty associated with it, it creates an attractive element for students. They know what is going to

happen. They have just been through an angst-filled time and they don't want to relive that history. Many of you are wanting some of this certainty.

Professor Thompson (Biology) since it seems inevitable that some of our course delivery will be online next year, what expectations are we communicating to students about technology requirements and internet access and computers? What are we doing if they don't have this access?

Interim Chancellor Mitchelson said now that we have some time to get this organized, we can better address this. As part of their planning process there is a team looking at those access issues and we may not be able to fix them all, but we can get the individuals identified and do our best to provide assistance. He thinks there may be relief in that regard, because the state's COVID-19 relief package has provided 42 or 45 million. He estimates ECU will receive approximately 10 percent of that and some of those funds could be used to address the access issues. Some of these access issues are geographic and related to finding an internet access point. For those students, we will have to help them identify places they can get to for that access.

Professor Lockerbie (Political Science) expressed curiosity as to when faculty will know what their teaching load will be in the upcoming term. For instance, if you have a 3-course load in the fall, when will you know if it is a 2/1 or (and he hopes this would not happen), a 3/0.

Interim Chancellor Mitchelson said units should guard against anything that is a 3-0. The distributions will primarily be done at the unit level. The interaction between the faculty and the chair or the associate chair will be crucial to ensure that the course load is distributed properly and that the students will have access to a variety of curriculum. That will not be imposed from above, it will be part of the implementation process. There is a tremendous amount of autonomy with regard to those decisions.

Professor Chambers (Education) noted that Governor Cooper signed into a law a package of support to help various agencies with the crisis, but she did not see any support for higher education unless it was going toward pursuit of a vaccine. Was there other types of funding for higher education?

Interim Chancellor Mitchelson said there was, and it was around 45 million in funding for higher education. ECU should receive about 10%, so we expect 4 to 4.5 million dollars.

Professor Chambers asked if that would still leave us about 5 or 6 million short, once you take the CARES act funding into account?

Interim Chancellor Mitchelson said the money comes with restrictions on how it can be spent, and we already know that expanding student access to technology and the internet will be part of what the funds will have to be used for.

Professor Su (Geography, Planning, and Environment) asked a question of clarification: whether the 8-week block is for all courses or it will be left to units to identify which of the courses will go to the 8-week block and which will stay on a 15-week schedule?

Interim Chancellor Mitchelson said there won't be complete freedom in units deciding which courses will go 15 weeks and which go 8 weeks. There will be some process to define exceptions to the 8-week blocks. Yes, there will be 15-week courses, but they should be relatively few in number if we are going to get through this next academic year as a whole. We can't simply open up the floodgates and give people choice. Our intent is to return to a situation in the future where you choose when you

want to do an 8-week course or a 15-week course, dependent on whatever course you are teaching or program you are in. He noted again that increased frequency often results in better student outcomes.

Professor Grodner (Economics) said anyone who teaches summer school has two versions of at least some of their courses and he wonders if it would be possible to just divide the semester into four 4-week blocks (like summer sessions) and just use the existing schedules for summer to get it done.

Interim Chancellor Mitchelson acknowledged that the 4-week intensive blocks Professor Grodner is suggesting are being considered by some institutions. It would take really good advising to make sure students don't get into situations that are counterproductive. He doubts we could simply dust off what we do in the summer and apply it.

Professor Bauer (English) noted that the Interim Chancellor said he would be receiving more information from the UNC System with details related to facilities and how to implement safety measures, but early June is when the schedule has to already be fixed to open for preregistration. How is that going to work when thinking about things like whether colleagues with immune deficiency issues should be filing an ADA claim so their chair will know they will be teaching online? How will the many moving parts about how registration will work be negotiated and ironed out when we won't have some of the answers until June?

Interim Chancellor Mitchelson said the answers will come in early June so we will be relatively fine in that regard. He admits that her questions are real and important. Vulnerable populations is one group that the HR group will be looking at. He does not know the disclosure process and the legality of that at this time. Paul Zigas sits on that team and he said we will make sure we treat people legally, fairly, and ethically. Whether that will take the form of an ADA claim or not, he does not know. We will do everything we can to protect those with comorbidities and vulnerable populations. Those faculty should probably teach online and work from home.

Professor Popke closed the question period and announced that he has worked with the faculty officers to establish the Calendar Implementation Taskforce because they wanted a way for faculty to provide feedback into this process. The way the Calendar Implementation Taskforce will interact with the Interim Chancellor's calendar committee tasked with working out some of these details (and the other teams/groups working on the public health plan) is still being considered. Faculty can communicate with this taskforce and send any feedback or additional concerns to them or to Chair Popke directly. He is gathering the concerns together and the taskforce is trying to make a plan. He will send a more formal announcement about it tomorrow and list the names of the Taskforce members. That Taskforce will be meeting at least weekly for the foreseeable future to provide some input into the process.

# IV. Report of Committees

### A. Nominating Committee for Faculty Officers

Professor Bauer (English), after expressing gratitude to the current faculty leaders, provided a slate of candidates for the 2020/2021 Faculty Officers.
